In the case of non-French degrees :

If the candidate does not hold a French M2 degree or a French engineering degree, their application will be examined by the Doctoral Commission for Exemptions and Waivers (CD3) for a degree equivalence assessment. This committee meets monthly (see dates on the ED PHYS website) and the complete application must be submitted to the ED no later than 10 days before the equivalence Commission meeting.

Thesis supervision:

- In accordance with the decree of 25 May 2016, the thesis supervisor must hold an HDR qualification or an equivalent qualification. He or she must be affiliated with the ED PHYS. A thesis supervisor may not exceed a supervision rate of 300% and a maximum of five supervised PhD students.
- A supervisory team (supervisor, co-supervisor, co-supervisor) may not consist of more than two people (with the exception of PhDs carried out under a joint supervision arrangement, a CIFRE agreement, or spanning two laboratories).
